What does the ETNDR?


acts as an interface platform for exchange and contacts

focuses on Waste and Water Management







PROM-ET DR (Promotion of Environmental Technology in the Danube Region)

- ✓ Networking of stakeholders and potential cooperation and project partners
- ✓ Developing common solutions and supporting their implementation
- ✓ Development of ETNDR-AT, ETNDR-BG, ETNDR-CZ, ETNDR-HU, ETNDR-HR, ETNDR-RO, ETNDR-RS
- ✓ Concepts of eight "Centers of Practice" (CPs) in Bulgaria, Germany, Croatia, Austria, Romania, Serbia, the Czech Republic and Hungary
- ✓ Thematic focus: waste and water
- ✓ Piloting of a CP-ET (Center of Practice Environmental Technology)







Forecast and new structure

PROM-ET DR (Promotion of Environmental Technology in the Danube Region)

- ✓ The Federal Ministry of Transport and Digital Infrastructure approved a
 grant in May 2014 for the preliminary project "PROM ET Danube
 Region" within the framework of the German Federal Program
 "Transnational Cooperation"
- ✓ Previous and future representatives could be develop to become PROM-ET Consortium Partner

Bio Energy Partnership Baden-Wuerttemberg – Serbia

- ✓ Opening event on 9 September 2014 in Stuttgart
- ✓ Funded by the Germany Agency for International Cooperation (GIZ)
