WORKSHOPS – AUTUMN 2020

9th Annual Forum

22nd October 2020, virtually

The plenary session focused on harmonious and sustainable development of the Danube Region. Following the programme agenda, three parallel sessions took place: the ecologic, the economic and the social perspective.

In the afternoon session Danube Interreg Programme presented aims of the new Danube Programme 2021-2027 based on the need and challenges across the Danube Region. The DTP will focus on strong cooperation in policy framework.

In terms of energy, the DTP is planning to have energy as one of the objectives as in the current period. Since the region has high energy dependency, lack of high energy security and still missing interconnections.

Concluding the Annual Forum, the Croatian Ministry of Regional Development gave closing words and welcomed the Slovakian Presidency for the upcoming year.

22nd September 2020 virtually

The PA2 participated and supported the project "Green Universities", co-financed by Visegrád Funds 03/2020-8/2021 aiming at the climate protection and sustainability. The university of Pécs, Hungary, organized this virtual event with the objective of sharing information and building network among universities interested in greening their activities.

Several universities from the Danube Region presented their steps and actions in order to be environmentally friendly. **Key words** *"think environmentally, be sustainable, social responsible"* were underlined by the speakers.

The three-week event was divided **into three thematic sessions: Empowering Citizens, Cohesion and Cooperation, Green Europe.** Cohesion and Cooperation participants stressed the importance of working closely together and deepening the partnerships. Moreover, future perspectives for EU macro-regions were presented. The third session focused on Green Europe aiming at the ambitious goal of carbon neutrality by 2050 based on the European Green Deal.
